No.GG/92/2021/MHK/102007/3588/C:- In exercise of the powers conferred by section 21 of the Gujarat State Reserve Police Force Act, 1951 (Bom. XXXVIII of 1951), the Government of Gujarat hereby makes the following rules further to amend the Platoon Commander/Armed Police Sub-Inspector, Class III, in the Gujarat State Reserve Police Force Recruitment Rules, 2016, namely :-

1. These rules may be called the Platoon Commander/Armed Police Sub-Inspector, Class III, in the Gujarat State Reserve Police Force Recruitment (Amendment) Rules, 2021.
2. They shall be deemed to have come into force from the 15<sup>th</sup> March, 2021.
3. In the Platoon Commander/Armed Police Sub-Inspector, Class III, in the Gujarat State Reserve Police Force, Recruitment Rules, 2016, in rule 4 to clause (a), for the second proviso the following proviso shall be substituted, namely :

“Provided further that the upper age limit may also be relaxed to the extent of three years in favour of a candidate who is working as a Constable, Class III or Head Constable, Class III or Assistant Sub-Inspector, Class III, in the subordinate service of the Police Department;”.
